Supplementary Regulations

1. The Motor Sport Club of Chelmsford Limited will promote a Clubsport Car Trial on 9th November 2008 at Woodham Ferrers, near Chelmsford, Essex.
2. The meeting will be governed by the General Regulation of the R.A.C.M.S.A., incorporating the provisions of the International Sporting Code of F.I.S.A., these SRs and any written instructions the promoting Club may issue for the event.
3. R.A.C. permit has been applied for.
4. The event is open to all fully elected members of the promoting club along with West Suffolk Motor Club, Falcon Motor Club, Sporting Car Club of Norfolk, Eastern Counties Motor Club, Wickford Auto Club & Weald Motor Club. It has been agreed that event membership of the promoting club may be purchased with the event entry for the sum of £1.00 if applicable.
5. The start will be at M.R. 167/799989. The event will take place solely on private land. Scrutineering will commence at 09.30 hrs. Any competitor not signed on by 10.30 hrs will be excluded. The event will start at 10.45 hrs.
6. The maximum number of entries per class is 25, the minimum is 4. The maximum number of entries for the event is 50, the minimum is 15. The organisers reserve the right to amalgamate classes or cancel the event should the minimum figures not be reached.
7. All vehicles will comply with R.A.C. vehicle and tyre regulations. Town and Country tyres will incur a penalty of 1 mark per test.
8. Current M.O.T. certificates will be requested at signing on.
9. All drivers must produce a valid Club Membership Card.
10. Classes are as follows:
 - a) (i) Front wheel drive cars - Minis ONLY
 - (ii) Front wheel drive cars - OTHER
 - b) Front engine, rear wheel drive cars
 - c) Rear engine cars
 - d) Open sports and kits cars. Also cars fitted with LSD and those excluded from other classes
11. Awards will be presented as follows:
 - a) Best overall performance
 - b) First and second in class
 - c) First Lady - provided 3 or more are entered
 - d) First Novice
12. The entry list opens on publication of these SRs and closes finally on Sunday 9th November 2008
