- 2. The meeting will be governed by the General Regulation of the R.A.C.M.S.A., incorporating the provisions of the International Sporting Code of F.I.A., these SRs and any written instructions the promoting Club may issue for the event.
- 3. R.A.C. permit has been applied for.
- 4. The event is open to all fully elected members of the promoting club along with West Suffolk Motor Club, Falcon Motor Club, Sporting Car Club of Norfolk, Eastern Counties Motor Club, Wickford Auto Club & Weald Motor Club.
